

In 2023, Aftermetoo achieved something we had been working toward for years. Five years after the #MeToo movement first galvanized public attention, in 2023 we launched www.aftermetoo.com, a massive comprehensive new website providing information, support and resources for people who are being sexually harassed at work in Canada.

I want to take a moment to thank everybody who helped us develop the site!

- More than 2,000 people who had experienced sexual harassment filled out our surveys and participated in interviews with us, telling us what they wanted and needed from the site.
- Hundreds of people contributed first-person accounts of harassment to the site, and/or recommended resources for our Resource Roulette feature.
- Dozens of sexual harassment researchers, lawyers, and mental health experts contributed their time and expertise to helping us develop our informational materials, many for free.
- Funding for the project was provided by Employment and Social Development Canada through its Workplace Harassment and Violence Prevention Fund program, and by the Ministry of Justice through its Justice Partnership and Innovation Program.
- The Canadian Women's Foundation provided critical support and partnership at every step of the work.



What We Did

In 2023, Aftermetoo launched www.aftermetoo.com.

Aftermetoo is a comprehensive and authoritative one-stop information shop, offering people everything they need to know about the laws related to sexual harassment in Canada, as well as how to protect their career, finances, and mental health from the damage that harassment so often causes.

- 100% Canadian and fully bilingual
- Information about the laws that apply to you, as well as how to protect your career, finances, and mental health: 176 articles, totaling 670,000 words
- Legal information is geolocated and customized for your jurisdiction
- Dozens of first-person stories, plus the option to upload your own
- A crowd-sourced set of media (TV, movies, podcasts, music, games, and quizzes) that people found helpful when they were being harassed
- Links to geolocated community resources near you from the 211 national database




In 2023, our visitors grew steadily, increasing by 68.96% month over month. The bar graph shows this consistent rise, highlighting our expanding reach throughout the year.



PROPORTIONAL REPRESENTATION OF USERS BY REGION ACROSS CANADA




PEOPLE THINK AFTERMETOO IS HELPFUL

In 2023, 93.3% of users who visited the website told us that they think the website will help.




PEOPLE RECOMMEND AFTERMETOO

Since 2019, Aftermetoo has been working in partnership with the Canadian Women's Foundation (CWF) to execute a variety of projects aimed at combating workplace sexual harassment, including the development of the digital property described in this report. The projects have been co-managed, but the majority of the funding has resided with and been disbursed by CWF.

Consequently, the figures presented in this report do not fully represent the scale and scope of Aftermetoo's activities, nor do they fully capture the costs of building and maintaining the digital property we launched in 2023.














About Aftermetoo
